Motion to Compel Discovery Illinois Cook County Circuit

November 12th, 2018 - If the motion is granted and the court finds that the refusal or failure at issue in the motion to compel was without substantial justification the court will require the offending deponent or party or the representing attorney or both to pay the moving party the expenses incurred in obtaining the order including reasonable attorneys fees

Common Examples of Motions NY CourtHelp

November 12th, 2018 - Or a party can make a motion to make the other side give the discovery that he or she was asked for by making a motion to compel See CPLR 3124 If a party ignores the courtâ€™s order compelling discovery the other side can ask the court to punish him or her for ignoring the courtâ€™s discovery order
